The trust is designed to strengthen every aspect of Oregon's culture through the development of a permanent endowment that will grow to more than \$200 million.

Since 2002, Oregonians have contributed over \$5.3 million to the Oregon Cultural Trust to help the arts, heritage and the humanities thrive. The State of Oregon has thanked them with a 100% tax credit for their gift.

When you make a gift to the CULTURAL ARTS CENTER and a subsequent matching gift to the Oregon Cultural Trust; you will be eligible for a 100% tax credit on your gift to the Trust. That means you can double your contribution to Oregon arts and culture! Investing in Oregon's arts and culture has never been easier or more important. The process is simple: First, make a contribution to the Hillsboro Community Foundation for the Cultural Arts Center. Second, make a matching gift to the Oregon Cultural Trust. Third, claim your tax credit, - up to \$500 for individuals, \$1000 for couples filing jointly or \$2,500 for corporations - when you file your Oregon State income tax returns.
